

Twisted Things - A place for artistes to grow

Choose the Plan that works for you and your art business.

We are offering a few options for our Resident artists so we can work with anyone's budget.

Rotating Artist Membership:

This plan will allow you to pay only \$150.00 a month with 25% of your sales going to Twisted Things. This plan is month to month and is subject to monthly review where sales, marketing, and artist involvement will be considered for renewal.

Rotating Artist Membership B:

This plan will allow you to pay only \$200.00 and keep all of your profits. This plan is month to month and is subject to monthly review where sales, marketing, and artist involvement will be considered for renewal.

The Artist Membership:

When you pay for three months at once you will save \$75.00, That's \$175.00 per month, and keep all your proceeds during the introductory time of initial agreement. The cost to you is only \$525.00 for three months. This plan is subject to monthly review where sales, marketing, and artist involvement will be considered for renewal.

The Resident Artist Membership.

When you pay for all six months at once you will save \$300.00 and keep all your proceeds during the introductory time of initial agreement. The cost to you is only \$750.00 for 6 months. Making it \$125.00 per month and saving you a third of your cost. This plan is subject to monthly review where sales, marketing, and artist involvement will be considered for renewal.

The Consignment Membership

When you become a consignment artist you have the same benefits our other plans offer. Bring in the pieces you would like to consign and we will pick out what best fits the stores atmosphere. You can put in as little as you want or we will house a suitable amount of your stock. On occasion we may suggest you rotate out a few pieces to keep things fresh. Consignment is a 50/50 split, however if you are able to make \$200 retail each month for two consecutive months we will drop your consignment to a 30/70 split in your favor. If you are unable to make \$200 in retail sales for 2 consecutive months you will revert back to the original 50/50 split, but if you are able to once again make \$200 retail each month for two consecutive months we will again drop your consignment to a 30/70 split in your favor. If it appears that your art may not suit our area and isn't selling, we may ask to end out consignment arrangement. Should this happen, you will be given 30 days to pick up your art. Please contact us to make special arrangements if you need longer than 30 days. After 60 days your art will be considered abandoned and become part of Twisted Things stock.

No matter which plan you choose you're maximizing your time and money. Think of the cost, time, and energy of booking, staffing, attending, traveling, and selling your goods at these weather dependent events. Even when placed inside there is always the gamble. Your customers now have a location for you to send them on the safer travel days.

How Much Art may I stock in the store?

The amount of items that would you could sell on a six foot table. Exceptions will be made for larger medium pieces, including but not limited to furniture, large framed art, and sculptures. Your items will not

be placed on a standard six foot table. They will be displayed in a beautiful presentation with a purposeful flow directing the customer throughout the store. Uniting the talents of our resident artists to create a well rounded and truly unique, and enjoyable shopping experience for our customers.

*Twisted Things reserves the right to decline specific pieces based on subject matter. Should this occur an explanation will be provided a different item may be stocked in its place.

*Twisted Things reserves the right to control the quantity of items being stocked in the store, to either increase or decrease. This may include but is not limited to quantity of similar items, duplicates/backstock or size.

Inventory

We will be using the Ricochet POS System software which allows for easy inventory control and sales review from the artist's home. Each item receives its own unique barcode which we will print out for you when you check in at the shop. Ensure each of your items has a price and short description attached.

We highly suggest that information about the item and business info be included on the tag in addition to the printed barcode we will supply.

Artist Bio

We request an artist bio in order to educate our staff and customers about your work. This will also be posted in the store. Details about how to write up a bio will be included in the inventory packet you'll receive.

Referral bonus.

Should you refer a new artist that is accepted and has paid for their plan, you will receive a \$20 credit towards your next plan. You can refer more than one artist.

You receive free access to business classes and lectures provided by Twisted Things during your plan to help you grow your own art business.

Twisted Things will assist you with networking and finding other venues and events to sell your art at.

Payments

You will receive your profits via Paypal or in check form that you can choose to have mailed to you or have made available for pick up during store hours by the 15th of the month.

Billing

Due the 25th day of each month if in a month to month plan, or on the 25th day in the last month of your current plan to renew or try a different plan.

Payments can be made via Paypal to twistedthingsypsi@gmail.com which must include Paypal fees of 2.9% of the total funds + \$0.30, or you may use the 'friends and family' option to avoid the Paypal fees. You can always pay in cash at the store or choose for Twisted Things to withhold your next plan payment from your profits. Should you have an issue with making your payment on time, please contact us and we will do our best to work with you. Plans must be consecutive to retain the introductory offer. If you decide not to continue with a plan going forward, please contact us two weeks before the end of your plan and arrange an appointment to check out and pick up your art. If you allow your plan to expire with no communication to Twisted Things your art will be considered abandoned and be sold with all profits belonging to Twisted Things until the art is all sold or arrangements are made to collect the art. Twisted

Things will make attempts to contact you before your art is considered abandoned, and once a week until it is all sold or an appointment to check out and pick up has been made.

All plans are subject to monthly review where sales, marketing, and artist involvement will be considered for renewal.
